- 1. Main Cover Page: A sample format enclosed as Annexure-I
- 2. Outer Cover: As per sample format Sky Blue Colour with Black printing
- 3. Title Page (1st Inner page): A sample format is enclosed as Annexure-II
- 4. Declaration by the student: A sample format is enclosed as Annexure-III
- 5. Certificate by Guide/Co-Guide(s): A sample format is enclosed as Annexure-IV
- 6. Table of Content
- 7. Abbreviations

INTRODUCTION

- 1. Background of Study
- 2. Need and Justification of Study

REVIEW OF LITERATURE

Interpretative description of reviewed literature <u>under relevant subheadings</u>; an example given of subheading for a study is given below:

- Prevalence and incidence of insomnia in patients with mental illness
- Clinician's knowledge about insomnia in patients with mental illness
- Therapies for management of insomnia in patients with mental illness

<u>Note:</u> It should be synthesis and critical evaluation of reviewed literature under particular sub-head rather than annotated bibliography or chronological summary of each reviewed research paper. [5-7 most recent studies]

METHODOLOGY

- 1. Research Design
- 2. Research Setting: A brief description about research setting
- 3. Target Population (As Applicable)
- 4. Inclusion and exclusion criteria for sample selection
- 5. Sample size calculation
- 6. Variables
 - i. Independent, dependent/ outcome and extraneous variables for experimental studies
 - ii. Research variables in observational/ qualitative studies
- 7. Procedure for Data Collection
- 8. Data Management
- 9. Ethical Considerations

NOTE: In experimental study, follow consort chart/ guidelines (refer: https://www.equatornetwork.org/reporting-guidelines/) to write methodology and include randomization, control group, intervention, blocking, allocation concealment, outcome variables etc.

REFERENCE

- 1. List reference in the order it is referred in the text
- 2. Follow <u>Vancouver's Style</u> of reference writing.

ANNEXURES

i. Patient information sheet and informed consent (In Hindi & English)

SPECIFIC INSTRUCTIONS

I. Font:

Font style: Times New

Roman Font size:

- 12 for the text throughout
- 14 point-Bold caps for section title [Introduction, Literature Review & Methodology etc]
- 12 point-Bold for section headings
- 12 point-Bold Italic for subsections
- All headings should be left aligned, except chapter headings, which should be centered.

II. Spacing/ margins/ Printing:

- 1.5 spaced throughout the manuscript of proposal.
- 1½ inch margin in left and one inch in upper, lower and right side of the page.

III. Page Layout:

- Begin each new section i.e. Introduction, Literature review and Methodology on a new page.
- Preliminary pages to be numbered in Roman numerals.
- Proposal manuscript page numbering must begin from first page of Introduction till end including references; using Arabic numerals for page numbering.
- Page numbering at bottom in the centre of each page.

IV. <u>Captions and Numbering (Tables and Figures):</u>

- Each Table and Figures / illustrations should carry a number and caption that clearly describes the nature of data presented.
- Each table and figures/illustrations should carry Arabic numbers separately; and number them consecutively throughout, in the order in which they are placed in the text.
- <u>Title</u> must be placed at the <u>top of the table</u> and for figure title must be placed at the bottom of the figure or illustration.

V. Number of Pages in Synopsis:

Dissertation proposal must be as brief as possible without losing any essential component; ideally it would be about 10 pages for the content except cover pages & appendices. However, variation may be accepted as per the nature of the study.

VI. Paper: A4 executive bond

VII. Grammar and Spelling:

- A good quality language and grammatical editing must be done; if needed help of a language expert may be taken.
- Use simple language.
- Avoid fancy and technical jargon.
- Avoid long sentences clubbing many ideas together.

VIII. Outer Cover of Dissertation Synopsis

- i. Printed on A4 executive bond with Transparency at front and back with spiral binding.
- ii. Name of the student, batch year and specialty must be published at front cover as specified.

IX. Number of Dissertation Synopsis Copies to be Submitted

i. One (01) hard copy and one (01) soft copy in .pdf format in Pen Drive of the compete dissertation proposal from cover page to the last appendix must be submitted to Concerned Dean, Atal Bihari Vajpayee Medical University, UP, Lucknow.
